



## **2017 GERSON PRACTITIONER Intern - Resident - Certified Fee Schedule**

**Note:** Prices may vary depending on who is assigned your case.

### **Initial Gerson Therapy Consult for NEW CLIENTS (APPROX 1.5 to 2 HRS) \$200 - 500 USD:**

This is an online video meeting consultation that covers all the necessary information to start the home Gerson Therapy with direction and supervision by your practitioner. The session includes an **overview** of how the Gerson Therapy works at home, **discussion of the baseline lab test results and analysis**, **specific instruction** on the Gerson Therapy and **initial protocol** implementation specific for the client. It is important to note that prior to the initial consultation time, your practitioner will have spent 1-2 hours reviewing the registration forms, medical information and lab test results to create a template protocol, which will then be finalized during the consultation. Prior to the consultation, the client must provide the current vitals, height and weight, and baseline photos (front and side view – standing) via email. Following the Initial Consultation, client will be considered an **ESTABLISHED CLIENT**.

### **Gerson Therapy Question & Answer Session for NEW CLIENTS (30 minutes) \$50 USD:**

This is an online video meeting consultation with your practitioner who will answer your questions regarding Gerson Therapy, how this distance-based direction and supervision works, and requirements for the therapy. This appointment session can be a one-on-one meeting or as a video conference with family members who are not necessarily in the same location.

### **Follow-Up Gerson Therapy Consult for ESTABLISHED CLIENTS ONLY (30-45 minutes) \$120 - 200 USD:**

This is a regularly scheduled online video meeting follow-up review consultation (usually every 4-6 weeks) to report on the client's progress in the home Gerson Therapy. The Gerson protocol is adjusted (fine-tuned, reduced or intensified) depending on the lab test results and patient signs and symptoms review. Client must report the current vitals and weight prior to this meeting.

### **THE FOLLOWING STATEMENT REFERS TO COMMUNICATION OPTIONS LISTED BELOW:**

#### **Email Communication :**

This is the **PREFERRED** communication method to contact your practitioner. Some questions require researching, which will require time spent by your practitioner to appropriately respond in a written format for your reference.



**Text Messaging (mobile number will be provided to ESTABLISHED CLIENTS ONLY that are US-based):**

This method of communication will receive almost instant brief response from your practitioner most of the time. It is only used for an urgent question or comment that is VERY short. Extended questions need to be communicated via email and may be subject to additional fees.

**Phone Calls (calls made by your Gerson Practitioner in response to a request from email or text messaging or voice mail):**

Phone calls are made only by your practitioner, **IF NECESSARY**, in response to emails, text messaging or voicemail that is urgent or an emergency (rare) in nature. Otherwise calling and leaving messages for your practitioner to call back are **discouraged** as it is an inefficient use of time in his or her very busy schedule.

If you just need to talk to your practitioner, **PLEASE MAKE AN APPOINTMENT** by sending a request via email or text message (for established clients only. If sending text for the first time, identify yourself).

**Note:** Your practitioner does not return international phone calls. Please send an email inquiry to them instead.

**IMPORTANT: The BEST and MOST EFFICIENT way to communicate to your Gerson Practitioner and get a response is via email.** Response is up to 2 business days, but sometimes earlier. Text messaging is **ONLY** available for established clients as stated above.

**EMAILS ARE PREFERRED BECAUSE COMMUNICATION IS IN WRITTEN FORM THAT IS FOR THE RECORD**

**NOTE: If you have become a client, it is highly recommended that you sign up for a free secure email account at [www.protonmail.com](http://www.protonmail.com).** This method of communication between you and your Gerson doctor insures end-to-end encryption and all attachments are very secure and encrypted.

**Web Video Meeting Software:**

Gerson Practitioners use Zoom, a web-based video conference software to conduct your consult and follow-up meetings. Please go to [www.zoom.us](http://www.zoom.us) and sign up for a free account. Then go to the **Download** section and download the **Client Meeting** software to your computer desktop or laptop.
